



Assurance that personal data is safe with you

Your data protection officer has a lot of responsibility

The role of the Data Protection Officer is to act as an independent advisor to the most senior level of management, typically the CEO. Some organisations are required by law to have a Data Protection Officer, others choose to appoint one to provide independent assurance for stakeholders that personal data are being handled appropriately.

The DPO provides guidance on data protection best practice, including reviewing Data Protection Impact Assessments, and will audit and report regularly on the organisation's regulatory compliance. They'll also be the contact point for the ICO and for data subjects when appropriate.

- Your DPO must be independent they can't be a senior decisionmaker or involved in performing data processing
- It's a professional position that requires appropriate qualifications and experience
- You're required to give the DPO the right level of support, authority and ongoing training
- You must consult with the DPO when making decisions about processing of personal data

How it works
